TERMS AND CONDITIONS:

- 1 Course fees are payable 14 days prior to commencement of classes.
- 2 The learner undertakes to attend and actively participate in all classes with a minimum attendance of 85%.
- 3 Students cancelling 14 days prior to the course will have 50% of the fees refunded, less non-refundable charges.
- 4 Students cancelling 13 days or fewer, prior to the course will be charged a cancellation fee equivalent to 75% of tuition.
- 5 Lessons not cancelled 24 hours prior to the scheduled time will be charged for in full.
- 6 Avenue English will give no refunds of tuition once the student has started his/her course. At the discretion of Avenue English, the student may be able to join another course at a later date.
- 7 Lessons/classes are only valid for 3 months after the scheduled start of the course, unless lessons/classes have been delayed by Avenue English.
- 8 In the event that it is impossible for AE to continue providing its services due to force majeure for a maximum period of 18 months (i.e. due to natural disasters, pandemics, strikes, wars, riots or nuclear accidents), students will be offered a voucher for the remaining course.
